### RESOLUTION

**November 13, 2021** 

Nº 3

Tashkent city (Republic of Uzbekistan)

On the conduct and results of doping testing of athletes of the XVI World Championship among men, the VII World Championship among women in fire and rescue sport

Guided by the resolutions of the World Anti-Doping Codex (further - the Codex), the International Standard for Testing and Investigation, the International Standard for Therapeutic Use Exemptions (further - the Standard) of the Prohibited List by WADA (further - List) and based on the decision of the meeting of the Anti-Doping Disciplinary Committee of the International Federation of Firefighters and Rescuers from 1<sup>st</sup> September 2021, received at the Joint Meeting of the Ground Jury, team officials and members of the Anti-Doping Disciplinary Committee of the International Federation of Firefighters and Rescuers, unanimously there was defined the procedure and number of samples of doping testing of athletes of the XVI World

Championship among men, VII World Championship among women in fire and rescue (fire-applied) sport «Karaganda - 2021» (Republic of Kazakhstan).

In the following categories:

## «Climbing with the hook ladder» - 11 people (3 samples from men, 8 samples from women:

- men (athletes) who showed three best results (1st, 2nd and 3rd places) in the preliminary races and one sample from the athlete who was chosen by lot;
- women (athletes) who took 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places, after the preliminary races; **«Overcoming the 100-meter obstacle course»- 8 people (8 samples for men:**

- men (athletes), 8 samples for athletes by lot.

Competition drug testing (biological sampling) in the amount of NINETEEN samples were 19 players, including: 11 - athletes (men), 8 - athletes (women); the Republic of Belarus - 4, the Republic of Kazakhstan - 2, the Mongolia - 1, the Russian Federation - 6, the Republic of Poland - 1, the Slovak Republic - 2, the Republic of Uzbekistan - 1, the Czech Republic - 2.

Having heard and discussed the report of the head of the Disciplinary Anti-Doping Committee of the International Sport Federation of Firefighters and Rescuers Z.Nytra, XXII International Conference of International Association «The International Sport Federation of Firefighters and Rescuers» has decided:

1. To approve the results of the conclusion of the doping testing of athletes of the XVI World Championship among men, the VII World Championship among women in fire and rescue (fire-applied) sport. The doping samples were selected by the commissioners of the RSE «National Anti-Doping Center» of Almaty in accordance with the rules of the World Anti-Doping Organization (WADA). The analysis of the samples was carried out by the Dresden Institute of Doping Analysis and Sports Biochemistry at the address: Dresden, Dresden str., 12, accreditation of the World Anti-Doping Agency D-PL-11245-01.

All tested doping samples have a negative result, with the exception of two doping samples. Prohibited substances in the amount of 3 substances HEPTAMINOL, OXILOFRINE (METHYLSYNEPHRINE), OCTODRINE (1,5 DIMETHYL HEXYLAMINE) were found in the sample belonging to the athlete of the national team of the Republic of Kazakhstan Daniil Puzikov, prohibited substances in the amount of 1 substance 5-METHYLHEXAN-2-AMINE were found in the sample belonging to the athlete of the national team of the Republic of Poland Selivnyuk Rafal.

- 2. Taking into account the circumstances of the use of these drugs, their features, explanatory documents of athletes, decisions of the Disciplinary Anti-Doping Committee, disqualify the athlete of the national team of the Republic of Kazakhstan Daniil Puzikov under paragraph 1 of the WADA Code for a period of 2 years, disqualify the athlete of the national team of the Republic of Poland Selivnyuk Rafal under paragraph 2 of the WADA Code for a period of 1 year.
- 3. Consider the prevention of cases of doping in sports as a priority area of sports activity of the International Sport Federation of Firefighters and Rescuers and national organizations in fire and rescue sport.

- 4. To note the positive and coordinated activities of the members of the Disciplinary Anti-Doping Committee Z. Nytra, M. Andrienko, S. Islamov on the organization and conduct of doping control of athletes of XVI World Championship among men, VII World Championship among women in fire and rescue (fire-applied) sport at a high professional level.
- 5. To bring the results of doping testing of the XVI World Championship among men, the VII World Championship among women in fire and rescue (fire-applied) sport to the attention of managers, coaches, medical personnel and athletes of national teams.
- 6. Recommend that the countries hosting the World Championships consider increasing doping tests up to 30.
- 7. Heads of ministries, departments, associations and federations to organize final testing on the course «Anti-Doping» to verify the knowledge gained about raising awareness of athletes, athletes' personnel and other persons about anti-doping rules. In case of successful completion of the final test (more than 8 points out of 10), the athlete receives a certificate certifying the completion of distance learning, both in Russian and in English languages. The certificate is valid until the end of the calendar year in which it was received.
